Bank Loans- Many a slip between the Cup and the Lip: AIMO Survey Results

All India Manufacturers' Organisation founded by Bharat Ratna, Sir M. Visvesvaraya in 1941 represents the MSMEs in the country. With the initiative of Shri K.E Raghunathan, immediate past president of the organisation AIMO has conducted a survey between 24th May and 30th May 2020. The survey has received 46525 responses. The participants were MSME owners (49%), employees (17%), self employed (16%), experts (11%) and corporate CEOs (7%).

Mr. K.E. Raghunathan says, "35% of MSMEs and 37% of the self employed see no chance of recovery in their business and they are shutting down. India has 65 million MSMEs employing over 150 million people and over 130 million people are self-employed. This kind of mass destruction of business has never happened". [Read More..](#)

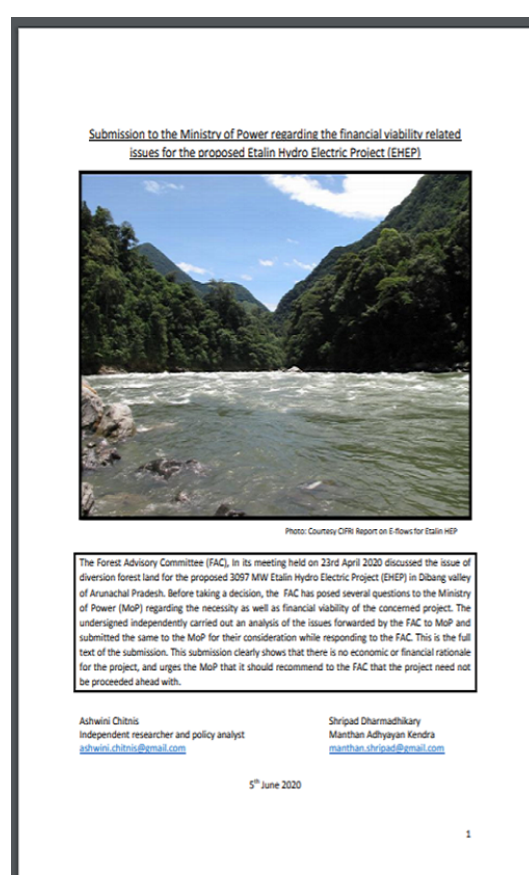


Comments and Objections of Civil Society Groups & Members on the Draft Electricity (Amendment) Bill 2020
